BIDDERS PROPOSAL

BLADE: Trip design- trip-edge preferred with four (4) vertical compression springs, V plow capability, 8 ½ ' width, powder coated.

HYDRAULICS: Multi-position capability, Dual action cylinders with hydraulic circuits to lock blade, 1 ½ " single acting lift cylinder, 3.25 GPM pump, 2250 psi relief valve, angling cylinder cushion valves set at 3500 psi.

POWER UNIT: 2HP, 12 vdc motor, gear pump directional control valve, 2 plug connectors from plow to vehicle. 8 Button "Fish-Stik" hand held control.

LIGHTS: Dual beam low profile halogen headlamps with park/turn signals, plug connection to existing harness to provide auto switching to plow lights when plow is attached, OEM compliant.

ATTACHMENTS: One piece, drive in, fully detachable, self-adjusting vertical jack stand, single handle release, automatic lift arm retraction, custom designed vehicle frame attachments, adjustable T-frame height.
