



# Schoharie County Agricultural Districts Open Enrollment Form



Pursuant to Article 25-AA of the New York State Agriculture and Markets Law, as amended in 2004, the Schoharie County Board of Supervisors has designated the time period from January 30-February 28 as the Annual Open Enrollment Period during which time farms may join an existing certified agricultural districts.

This form is to be signed by the **landowners** of parcels used in agricultural production who are requesting inclusion of those parcels within existing agricultural districts certified by the Commissioner New York State Department of Agriculture and Markets. The information obtained on this form will be used by the Schoharie County Agricultural and Farmland Protection Board (AFPB) to evaluate the appropriateness of such request. The AFPB will evaluate said request and make recommendations to the County Board of Supervisors (Board) for inclusion in existing certified agricultural districts. Approval by the AFPB does not guarantee or imply that the Board will recommend the parcels to the Commissioner of the New York State Department of Agriculture and Markets and does not guarantee or imply that the Commissioner will certify the parcels for inclusion in existing certified agricultural districts.
