Schoharie County 911 can sent text messages of dispatched calls to responders. A text message can be sent to a cell phone.

Since this service depends on a phone line, Schoharie County 911 is not responsible for lost, multiple, misdirected, late or incorrect messages. If you cannot read your devices display due to a flashing display or you do not receive the whole message **DO NOT** call Schoharie 911 to find out where the call is.
